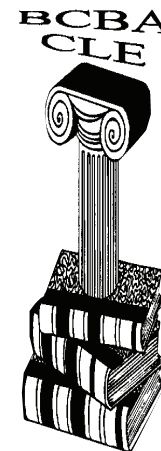
**Note: Attorneys requesting Pennsylvania CLE credit must submit an additional \$15.00 fee for processing.**

All other attorneys must complete 24 hours of accredited Continuing Legal Education each biennial registration period, 4 hours of which must be in ethics and professionalism and 1 of which must be a diversity, inclusion and elimination of bias credit.
